The learned Government Advocate (Criminal Side) appearing for the State would submit that on the basis of the complaint of the petitioner, CSR.No. 326 of 2024 came to be registered and at the enquiry, the third respondent has informed that he has already filed an appeal, challenging the judgment and decree passed in A.S.No.32 of 2023 in O.S.No.196 of 2018 and on that basis, the complaint was ordered to be closed.

4. Recording the submission made by the learned Government Advocate (Criminal Side), this Criminal Original Petition is dismissed.
