2. Heard both sides and perused the materials available on record.

It is the case of the petitioner that on 26.12.2020, there was a General Body meeting conducted and the petitioner was selected as the Secretary of the Valampuri Vaduganathan Higher Secondary School Society, Ponnamaravathy. Hence, the petitioner and other ex-officio members were taken charge with effect from 26.12.2020. Subsequently, on 31.12.2020, they sent a proposal to the third respondent for getting approval for the elected executive management committee. The same has
