The petitioner's earlier efforts to secure suspension of sentence ended in vain.

We do not find any change in circumstance.

2. The learned counsel appearing for the petitioner pleads that on medical grounds, the sentence imposed on the petitioner may be suspended. The report submitted by the learned Additional Public Prosecutor on the other hand, indicates that neurosurgical intervention is not needed at present. This report is dated 04.11.2024.

3. We are satisfied that no case for granting suspension of sentence has been made out. This petition is dismissed.
