credit of Crime No.13 of 2024 before the learned Judicial Magistrate, Devakottai, by
this Court in Crl.OP(MD)No.10179 of 2024, dated 10.07.2024.

2.The learned counsel for the submits that even though originally an undertaking was given to deposit a sum of Rs.10,000/-, the same was meant towards the value of the goats. Subsequently, A1 and A2 were arrested and the goats were recovered.

3. In view thereof, the petition stands allowed and the condition to deposit a sum of Rs.10,000/- is cancelled. All other conditions in the order dated 10.07.2024, shall remain unaltered.

4. In view of the modification being permitted, one week time is extended to comply with the other conditions from the date of receipt of a copy of this order.
