5. No prejudice will be caused to the first respondent, if the application of the petitioner dated 27.05.2024 seeking for correction of his name, date of birth and place of birth is considered on merits and in accordance with law within a time frame to be fixed by this Court.

For the foregoing reasons, this Court directs the first respondent to pass final orders on merits and in accordance with law on the petitioner's application dated 27.05.2024 seeking for issuance of corrected passport with regard to his name, date of birth and place of birth within a period of one week from the date of receipt of a copy of this order.
