2.The case of the prosecution is that the accused started a jewelry shop in the name and style of 'Arusha Jewelry Shop at Virudhunagar and received deposits from the general public including the defacto complainant and thereafter, failed to return it after maturity. Hence, the complaint.

3.Heard. Perused the materials available on record including the First Information Report.

4.Considering the facts that there are 1123 victims and the petitioner is being implicated by the co-accused and the investigation is in a very nascent stage, this is not a fit case for enlarging the petitioner on anticipatory bail.
