In view of the same, this petition is allowed and the condition No.6(b), ie, to make a non refundable deposit of Rs.50,000/- (Rupees Fifty Thousand only) is modified to the effect that the petitioner is directed to deposit a sum of Rs.20,000/- (Twenty Thousand only) to the credit of Environmental Committee Operated by Registrar (Judicial).

4. Time is extended for one week for producing sureties from the date of receipt of copy of the order.
