PETITION FOR ANTICIPATORY BAIL Under Sec.482 of BNSS

PRAYER :-

For Anticipatory Bail in Crime No.6 of 2024 on the file of the Respondent police.

ORDER : The Court made the following order :-

The petitioner/ A2, who apprehends arrest at the hands of the respondent police for the offences punishable under Sections 406, 408, 409, 420, 34 and 477A of IPC, in

Crime No.6 of 2024, seeks anticipatory bail.

2.The case of the prosecution is that the petitioner was the erstwhile President of M.M.241 Mondipatty Milk Producers Co-operative Society of Manapparai Taluk, Trichirappalli District. During that time, he swindled the amount of Rs.12,00,000/-. Hence, the complaint.

3.Heard both sides.

4.Considering the nature of the allegations that the petitioner being President of Co-operative Society, misappropriated the amount of Rs.12,00,000/- and considering the fact that the other employees were also involved in this case and also considering the argument made by the learned counsel for the petitioner that without prejudice to his contentions, the petitioner will deposit a sum of Rs.6,00,000/- to the credit of Crime No.6 of 2024, this Court is inclined to grant anticipatory bail to the petitioner with certain conditions.

5.Accordingly, as undertaken, the petitioner shall pay a sum of Rs.6,00,000/- (Rupees Six Lakhs Only) to the credit of Crime No.6 of 2024, without prejudice to his rights and contentions before the trial Court and produce the receipt/acknowledgement before the learned Judicial Magistrate No.III, Trichirappalli.

6. On production of such receipt, the petitioner is ordered to be released on bail in the event of arrest or on his appearance, within a period of four weeks from the date of receipt of a copy of this order, before the learned Judicial Magistrate No.III, Trichirappalli, on condition that the petitioner shall execute a bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties each for a like sum to the satisfaction of the learned Magistrate concerned and on further conditions that:

(a) the petitioner and the sureties shall affix their photographs and left thumb impression in the surety bond and the Magistrate may obtain a copy of their Aadhar card or Bank pass Book to ensure their identity;

(b) the petitioner shall report before the respondent police daily at 10.30 am for a period of two weeks and thereafter, as and when required for interrogation;

(c) the petitioner shall not tamper with evidence or witness either during investigation or trial;

(d) the petitioner shall not abscond either during investigation or trial;

(e) on breach of any of the aforesaid conditions, the learned Magistrate/ Trial Court is entitled to take appropriate action against the petitioner in accordance with law as if the conditions have been imposed and the petitioner released on bail by the learned Magistrate/ Trial Court himself as laid down by the Hon'ble Supreme Court in P.K.Shaji Vs. State of Kerala [(2005) AIR SCW 5560]; and;

(f)if the accused thereafter absconds, a fresh FIR can be registered under Section 229-A IPC.
