2.We are now informed that the 3rd respondent / Deputy Inspector General of Prisons, Trichy had considered the representation of the petitioner and passed an order, dated 22.08.2024 in No.106/୧୭/2024, rejecting the representation of the petitioner. The petitioner will have to naturally challenge the same in the manner known to law.
