When the matter is taken up for hearing, the learned Government Advocate (Criminal Side) appearing for the respondents 1 and 2 would submit that on the basis of the complaint given by the petitioner, FIR came to be registered in Crime No.144 of 2024 on 25.07.2024 for the alleged offences under Section 296(b) BNS, 2023 and Sections 3(a), 4(1) and 7 of Protection of Civil Rights Act, 1955 and that investigation is pending.
