Considering the facts and circumstances of the case and also considering the fact that the petitioner has got 80 previous cases, in such cases, where if a person is making a mockery of the condition, which is imposed in the earlier bail application that he should not involve in similar offences and is repeatedly involving in the same offence, this is an exceptional case, not grant bail.

5. Hence, this Petition is dismissed.
