Considering the nature of allegation against the petitioner that he had a relationship with the victim girl and had physical relationship even when she was a child and considering the fact that after continuous cohabitation, the petitioner left her to marry some other person, this is not a fit case for grant of anticipatory bail.

5. Accordingly, this Criminal Original Petition stands dismissed.
