Considering the fact that the petitioner is indulging in manufacture of crackers without license and considering the fact that the petitioner has got six previous cases, out of which, four are similar in nature and when earlier anticipatory bail is granted to the petitioner on condition that the petitioner will not involve in similar activities and when the petitioner is repeating the same activities manufacturing crackers without license, this is not a fit case for grant of anticipatory bail to the petitioner.

4. Accordingly, this Criminal Original Petition is dismissed.
