festival, the petitioner and other accused are said to have waylaid the defacto complainant and his brother and attacked the brother of the defacto complainant with deadly weapons and murdered him. Hence, the complaint.

3.Heard both sides.

4.Considering the nature of the offence that on account of enmity due to the temple festival, all the accused conspired together and waylaid the deceased and attacked him with aruval resulting in instantaneous death and also considering the allegation against the petitioner that the accused confessed that he only arranged the weapons for them, this is not a case for enlarging the petitioner on anticipatory bail.

5.Accordingly, this Criminal Original Petition is dismissed.
