PRAYER : FOR ANTICIPATORY BAIL IN CRIME NO.NOT KNOWN OF 2023 ON
THE FILE OF THE RESPONDENT POLICE.

ORDER : The Court Made the following order :-

The petitioners, who apprehend arrest at the hands of the respondent Police
for the alleged offence under Sections 294(b), 498(A), 506(ii) IPC, in Cr.No.Not
Known of 2023, seek anticipatory bail.

2.The case of the prosecution is that the defacto complainant got married with
one Maheshwaran, who is son of the petitioners herein on 26.01.2023. At that time of

marriage, 3 ½ sovereigns of gold were gifted to the defacto complainant by her parents. After marriage, the husband of the defacto complainant and his parents harassed the defacto complainant, demanding more dowry. Hence, the complaint.

3. The learned Government Advocate (Crl.Side) would submit that the complaint given by the defacto complainant in at enquiry stage and there is no First Information Report is registered against the petitioners.

4. Considering the facts and circumstances of this case and also considering the submissions made by the learned Government Advocate (Crl.Side), there shall be a direction to the respondent Police to complete the above said enquiry within a period of two weeks from the date of receipt of copy of this order.

5. With the above said direction, this Court is not inclined to grant anticipatory bail to the petitioners and this Criminal Original Petition is closed. Consequently, connected Miscellaneous Petition is closed.
