PETITION FOR ANTICIPATORY BAIL UNDER SECTION 482 OF BNSS

PRAYER :-

For Anticipatory Bail in Crime Nos.270 and 386 of 2024 on the file of the Respondent Police.

ORDER : The Court made the following order :-

The petitioner/accused, who apprehends arrest at the hands of the respondent

police for in connections with case in Crime.No.270 of 2024 for women missing, seeks anticipatory bail.

2.The case of the prosecution is that the defacto complainant's daughter, who went to the typewriting Institute did not return home till 9.20 pm. Hence, the complaint.

3. Heard the learned counsel for the petitioner and the learned Government Advocate (Crl. Side) appearing for the respondent Police and perused the materials available on record.

4. It can be seen that in respect of the same woman missing, two FIRs have been registered in two different police stations. Considering the fact that the missing woman has been traced, I am inclined to enlarge the petitioner on anticipatory bail in both case.

5. It will be open for the petitioner to approach the court for appropriate remedy. In case, both cases are proceeded, the learned Government Advocate (Crl. Side) would submit that the appropriate steps will be taken if there is overlapping in respect of the same incident. Be that as it may, the petitioner is enlarged on bail in both the cases with certain conditions.

6. Accordingly, the petitioner is ordered to be released on bail in the event of arrest or his appearance, within a period of fifteen days from the date of receipt of a

copy of this order, before the learned District Munsif Cum Judicial Magistrate, Aravakurichi, Karur District on condition that the petitioner shall execute a bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties, each for a like sum to the satisfaction of the respondent Police or to the Police Officer, who intends to arrest or to the satisfaction of the learned Magistrate concerned and on further conditions that:

(a) the petitioner and the sureties shall affix their photographs and left thumb impression in the surety bond and the Magistrate may obtain a copy of their Aadhar card or Bank pass Book to ensure their identity;

(b) the petitioner shall report before the respondent police as and when required for interrogation;

(c) the petitioner shall not tamper with evidence or witness either during investigation or trial;

(d) the petitioner shall not abscond either during investigation or trial;

(e) on breach of any of the aforesaid conditions, the learned Magistrate/ Trial Court is entitled to take appropriate action against the petitioner in accordance with law as if the conditions have been imposed and the petitioner released on bail by the learned Magistrate/ Trial Court himself as laid down by the Hon'ble Supreme Court

in P.K.Shaji Vs. State of Kerala [(2005) AIR SCW 5560]; and;
