This Criminal Original Petition has been filed to direct the learned Judicial Magistrate No.III, Thoothukudi, to complete the trial in C.C.No.1338/2017 within a time limit stipulated by this Court.

2. The learned counsel appearing for the petitioner submits that the petitioner is the defacto complainant in C.C.No.1338/2017 and as against the accused persons, three cases are pending in the same Court and the trial Court issued Non-bailable warrant against the accused persons, however, the same was not implemented by the respondent Police and the case has not been disposed of . Hence, this Petition has been filed.

3. The learned counsel appearing for the petitioner further submits that it would suffice if this Court directs the respondent Police to execute the Non-Bailable warrant issued by the trial Court against the accused persons and co-operate with the trial.

4. Considering the limited request made by the learned counsel appearing for the petitioner, this Court directs the respondent Police to execute the Non-Bailable Warrant issued by the trial Court against the accused persons and co-operate for early disposal of the case in

C.C.No.1338 of 2017. The learned Judicial Magistrate No.III, Thoothukudi, is directed to conclude the trial in C.C.No.1338 of 2017 as per the seniority.
