This application has been filed seeking to relax the condition imposed while granting suspension of sentence to the petitioners vide order dated 28.06.2024.

2. While granting suspension of sentence, the condition imposed was that the petitioners shall stay at Tirunelveli and report before the Inspector of Police, Tirunelveli Town Police Station, Tirunelveli District every day at 10.30a.m., until further orders.

4. The learned Additional Public Prosecutor stated that the petitioners are complying with the conditions from 02.07.2024 with out fail.
