3. Considering the the nature of the allegations that the petitioner and two other persons, forcibly committed penetrative sexual assault on the child by forcefully taking her to a secluded place, this is not a fit case for grant of bail to the petitioner.

4. The learned Additional Public Prosecutor would submit that the trial is in progress and so far 13 witnesses have been examined.

5. Therefore the prosecution is directed to conduct the trial expeditiously and the trial Court is also requested to take up the matter expeditiously for disposal. Accordingly, this Criminal Original Petition stands dismissed.
