3. When the matter is taken up for hearing today, the learned counsel appearing for the writ petitioners would submit that the writ petitioners may be permitted to withdraw these petitions with liberty to file civil suit before the competent civil Court.

4. Recording the submission made by the learned counsel appearing for the writ petitioners, these Writ Petitions are dismissed as withdrawn. The writ petitioners are at liberty to take appropriate proceedings in the manner known to law. No costs.
