ORDER

The present Habeus Corpus Petition had been filed by the petitioner complaining that her daughter who was born on 05.11.2003 had been found missing on and from 17.08.2024.

2. The petitioner suspected that her daughter would have gone away with the third respondent/ son of the sister -in- law of the petitioner.

3. The detainee got admission in B.E (EEE) in a college but she did not join the course. In this connection, a complaint had been lodged and First Information Report had been registered for the offence under Section 5(1) r/w. 6 of POCSO Act. The respondents were able to secure the girl.

4. We enquired with the girl and she stated that she would go to a home where she stayed. We also enquired with petitioner who was present in the Court.
