The above writ petition has been filed for the issue of a Writ of Mandamus directing the respondents 1 to 3 to issue patta for the suit lands situated in Rayavaram village of Thirumayam Tauk in Pudukkottai District obeying the civil court decree passed in O.S.No.101 of 2009 on the file of the District Munsit cum Judicial Magistrateat Thirumayam within a time frame as fixed by this Court.

2. The third respondent has filed a counter affidavit, wherein the following statement has been made:-

"It is respectfully submitted that the order of the civil court confirming the title over the property in favour of the petitioner and the petitioner is in adverse enjoyment of the said properties, it is
