The petitioner/A2, who apprehends arrest at the hands of the respondent police for the offences punishable under Sections 309(4), 311 & 351(3) of the Bharatiya Nyaya Sanhita, 2023, in Cr.No.199 of 2024, seeks anticipatory bail.

2.The case of the prosecution is that the petitioner and other accused are said to have snatched a sum of Rs.2,000/- from the defacto complainant at knife point for buying liquor. Hence, the complaint.
