Prayer : Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Certiorarified Mandamus, calling for records pertaining to the impugned order passed by the respondent vide his order in GSTN:33APEPM9250P1ZE/2018-2019, dated 29.04.2024 and quash the same as it is illegal, without jurisdiction and in gross violation of principles of natural justice and further direct the respondent to re-do the assessment afresh after providing an opportunity of personal hearing as per the provisions of the GST Act and to pass such further or other orders as this Court.

ORDER

The present writ petition has been filed challenging the impugned order passed by the respondent in GSTN:33APEPM9250P1ZE/2018-2019, dated 29.04.2024 for the assessment year 2018-2019 on the premise that the same is made in violation of principles of natural justice and also the procedure contemplated under the Tamil Nadu Goods and Services Tax Act, 2017.

2. It is submitted by the learned counsel for the petitioner that the petitioner is a registered dealer under the TNGST Act. The petitioner had filed their returns and also paid appropriate taxes.

3. It is submitted by the learned Counsel for the petitioner that show cause notice was issued on 26.10.2023. Neither the show cause notices nor the impugned order of assessment has been served on the petitioner by tender or sending it by RPAD, instead it had been uploaded in the GST portal. Hence, the petitioner was unable to access the GSTIN portal and was thus unable to

participate in the adjudication proceedings. It is also submitted that the petitioner had paid entire taxes. It is further submitted by the learned counsel for the petitioner that if the petitioner is provided with an opportunity, he would be able to explain the alleged discrepancies.

4. The limited issue that arises for consideration in the impugned order is the non-filing of GSTR-9 and the reconciliation statement in FORM GSTR-9C. It is submitted by the learned counsel for the petitioner that if the petitioner is provided with an opportunity, he would be able to explain the alleged discrepancies, i.e. non-filing of GSTR-9 and the reconciliation statement in FORM GSTR-9C.

5. The learned counsel for the petitioner would place reliance upon the recent judgment of this Court in the case of *M/s.K.Balakrishnan, Balu Cables vs. O/o. the Assistant Commissioner of GST & Central Excise in W.P. (MD)No.11924 of 2024 dated 10.06.2024*, to submit that this court has remanded the matter back in similar circumstances subject to payment of 25% of the disputed taxes. The learned counsel for the petitioner would submit that

the entire taxes have been paid and they may be granted an opportunity before the adjudicating authority to put forth their objections to the proposal.

6. Taking into account the peculiar facts of the case, wherein, the petitioner had reversed the entire Input Tax Credit and also paid the entire tax, this Court is of the view that the petitioner may be granted one final opportunity to put forth his objections, which was not objected to by the learned Additional Government Pleader for the respondent.

7. In view thereof, the impugned order, dated 29.04.2024 is set aside. The impugned order shall be treated as a show cause notice and the petitioner shall file their objections within a period of two (2) weeks from the date of receipt of a copy of this order. If any such objections are filed within the stipulated period, the respondent shall consider the same and pass appropriate orders in accordance with law after affording the petitioner a reasonable opportunity of hearing. If objections are not filed within the stipulated period, i.e., two weeks from the date of receipt of a copy of this order, the impugned order of assessment shall stand revived.
