Criminal Miscellaneous Petition filed praying that in the circumstances stated therein and in the petition filed therewith the High Court may be pleased to suspend the execution of sentence by granting bail in SC No.56/2016 dt.7/8/2023 on the file of the Learned VI Additional Sessions Judge, Madurai District pending disposal of the above Crl.A.

PRAYER in CRL A(MD)No.745 of 2023:

To admit this appeal on file to call for records from the lower court in S.C.No.562/2016 on the file of the Learned VIth Additional Sessions Judge, Madurai District and set aside the judgment dated 07.08.2023 by acquitting the accused and by allowing the Appeal.

Prayer in CRL MP(MD). 13016/ 2023 in CRL A(MD)No.829 of 2023:

To suspend the sentence imposed on the petitioner/appellant/accused No.1 in SC No.562/2016 dt.7/8/2023 on the file of VI Addl. Sessions Judge, Madurai and enlarge her on bail till the disposal of the above Crl.A.

PRAYER in CRL A(MD)No.829 of 2023:

To call for the record relating to the judgment passed in S.C.No.562 of 2016 on 07.08.2023 by the learned VI Additional Sessions Judge Madurai and set aside the same and acquit the appellant/accused-1 from all the charges leveled against her.
