3. In the light of the Full Bench decision of this Court in ***the Chairman, Bar Council of India, New Delhi Vs. S.M. Anantha Murugan*** reported in ***2017-4-L.W 549***, the relief sought for by the petitioner cannot be granted. Accordingly, the Writ Petition is dismissed. However, liberty is granted to the petitioner to work out his remedy in the manner known to law, if he is acquitted in the criminal case. No costs.
