ORDER

Despite the petitioner complying with the request of the respondents for keeping the land free of the overgrown Karuvelam trees so as to enable them to survey the land on the basis of the petitioner's representation, dated 20.06.2024, the same has not been conducted. Hence, the petitioner is before this Court for a direction that the survey, measurement and demarcation of the land belonging to the petitioner be done at earliest.

2. Apparently, the records would show that the representation was made by the petitioner on 20.06.2024. Pursuant to which he was informed that since there are overgrown shrubs in the premise, survey could not be take place. Thereafter, the same has also been cut and removed by the petitioner. Despite the same, no further action has been taken on the side of the respondents.
