2.Heard both sides.

3. It is seen that the petitioner has earlier been granted anticipatory bail by an order dated 14.12.2022 in CrI.OP(MD)No.19386 of 2021. Thus, the petitioner has not complied with the primary condition of depositing a sum of Rs.2,70,000/-. Therefore, the said order got expired itself, the petitioner is now filing the second application.

4. In view of the above order which was already granted, the petitioner, who did not file any modification application and also kept quiet, cannot be permitted to move the second application for anticipatory bail. Accordingly, the petition is dismissed.

5.However, considering the case is of the year 2021, the respondent police is directed to complete the investigation as early as possible.

6.With the above direction, this Criminal Original Petition stands dismissed.
