ORDER

This Criminal Original Petition has been filed to quash the FIR in Crime No.06 of 2022 on the file of the first respondent herein as against the petitioners.

2. Today, when the matter is taken up for hearing, the learned counsel appearing for the petitioners submitted that the issue has been amicably settled in between the parties and hence, this Court may permit the petitioners and the defacto complainant to produce the compromise memo before the first respondent police and this Court may also issue a direction to the first respondent Police to close the cases as “Action Dropped”.

3. The learned Additional Public Prosecutor appearing for the first respondent submitted that if the parties are produced the compromise memo, the first respondent police is ready to close the cases as “Action dropped”
