By producing the copy of the communication sent by the Tahsildar, Madurai East, to the learned Government Advocate in Na.Ka.No. 418/2024/Aa2, dated 19.02.2024, learned Government Advocate appearing for the respondents stated that the petitioner is residing at Poovanthi Village, Thirupuvanam Taluk, Sivagangai District and therefore, he has to approach the competent jurisdictional authority for issuing community certificate and the said 'Hindu Bauri Caste' has not been included in the list of Scheduled Castes in

Tamil Nadu and the same has not been notified in the Gazette by the State Government.

3. Recording the same, the Writ Petition is dismissed. If the petitioner has any other grievance, he has to workout his remedy before appropriate forum in accordance with law. No costs.
