This application has been filed seeking to relax the condition imposed while granting suspension of sentence to the petitioner vide order dated 26.07.2024.

2. While granting suspension of sentence, the condition imposed was that the petitioner shall stay at Salem and report before the Inspector of Police, Fairland Police Station, Salem every day at 10.30a.m., until further orders.

3. In the affidavit filed, it has been stated that the petitioner is an agriculturist and he could not perform his agricultural work . It is further stated that he had been complying with the conditions without any default right from the date of order.

4. Heard the learned Additional Public Prosecutor.

5. Taking into consideration all the factors the said condition alone is modified to the effect that the petitioner shall report before the respondent police/ Inspector of Police, Kadayam Police Station, Tirunelveli District on every Saturday at 10.30 a.m., until further orders.
