PRAYER: Writ Petition is filed under Article 226 of the Constitution of India, to issue a writ of Mandamus, directing the respondents to settle the petitioner's retirement benefits including gratuity, Commutation of pension, arrears of monthly pension from 30.04.2020 till the date of realization of amount as per the settlement dated 24.08.2022 under section 12(3) of ID Act 1947 w.e.f. 01.09.2019 payable to him with 18% rate of interest within the time that may be stipulated by this Court.

### **ORDER**

The instant writ petition has been filed by a Special Grade Tradesman of the respondent transport corporation, who obtained Voluntarily Retirement on 30.04.2020, seeking a mandamus for disbursement of the retirement benefits with 6% interest on the basis of settlement arrived at under Section 12(3) of the Industrial Disputes Act.

2. Seeking the said benefits, the petitioner has sent a representation on 06.02.2024. However, since there is no response, the present writ petition has been filed.

3. Considering the above said facts, the respondents herein are directed to confer the eligible benefits upon the writ petitioner with 6% interest from the due date till the date of disbursement within a period of twelve weeks from the date of receipt of a copy of this order.
