PRAYER: Writ Petition is filed under Article 226 of the Constitution of India, to issue a writ of Mandamus, directing the respondents i.e., the Principal Secretary to Government, Social Welfare and Nutritious Scheme Department, Social Welfare and Nutritious Scheme Department, Chennai and the Commissioner of Social Welfare, Social Welfare department, Chennai – 600 002 to revise the orders passed in the proceedings No. 35168/No.5(3)/2012 dated 01.07.2022 by ordering recovery of the sum of Rs.5,280/- i.e. the balance amount accrued from the petitioner's dated of joining in the society within a specified time frame that may be fixed by this Court.

The instant writ petition has been filed by a retired employee, seeking to expeditious disposal of his representation/revision pending before the first respondent herein.

2.According to the learned Counsel appearing for the writ petitioner, the second respondent has passed an order on 01.07.2022 ordering recovery of a sum of Rs.5,280/-. Challenging the said order, the petitioner has preferred a revision before the first respondent on 20.03.2024. Since the revision is yet to be disposed of, the present writ petition has been filed.

3.Considering the above said facts, the first respondent herein is directed to dispose of the revision filed by the petitioner within a period of twelve weeks from the date of receipt of a copy of this order after giving due opportunity to the writ petitioner.
