Prayer in W.P.(MD).No.10292 of 2021:

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus, directing the 2nd respondent to place the petitioner in the post of Assistant Engineer from the date of the petitioner regularization in the Entry level post i.e., 23.02.2006 and grant periodical promotion as per The Tamil Nadu Municipal Engineering Service rules 1997 and as well as G.O.Ms.No.125 dated. 27.05.1999 by considering the petitioners representation dated. 14.10.2020 within time frame fixed by this Court.
