Prayer in WMP(MD). No.19098 of 2024

Writ Miscellaneous Petition is filed under Article 226 of the Constitution of India, to extend the time given by this Hon'ble Court in WP (MD) No.18752 of 2024 dated 06.08.2024 and thus render justice.

Prayer in WP(MD). 18752/ 2024 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court Writ Petition, filed under Article 226 of the Constitution of India, praying this court to issue a Writ of Mandamus directing the respondents to accept the pending principal electricity due amount totaling Rs.43,81,735/- (Forty Three Lakhs Eighty one Thousand Seven Hundred and Thirty Five Only) and direct the respondents to forthwith restore the electricity connection of the petitioner or provide any other new connection on the petitioners or provide any other new connection on the petitioners land within the stipulated time fixed by this Honourable Court and the interest payable towards the Principal amount may be subject to the outcome of Electricity O.P.No.121/2019 on the file of Principal District

ORDER:- This Petition coming on for orders on this day and upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of Mr.C.Mayilvahan Rajendran, Advocate for Mr.V.Malaiyendran, Advocate for the Petitioner and of Mr.S.Deenadhayalan, Standing Counsel for the respondents, this Court made the following order:

“This petition is filed seeking to extend the time to comply with the order passed by this Court dated 06.08.2024.

2. This Court by an order dated 06.08.2024, directed the petitioner to deposit a sum of Rs.69,81,735/- excluding the amount already paid i.e, Rs.26,00,000/- to the credit of TANGEDCO.



3. The learned counsel appearing for the petitioner submitted that today he is ready to pay a sum of Rs.10,00,000/- (Rupees ten lakhs only) by way of demand draft and the remaining amount will be paid within three months.

4. In view of the said submissions, this Court directs the petitioner to hand over the demand draft of Rs.10,00,000/- to the TANGEDCO and pay the remaining amount within three months from the date of receipt of a copy of this order. It is made clear that only if the amount is deposited, the electricity service connection will be restored.

5. Accordingly, this miscellaneous petition is ordered."
