ORDER

The 2018 proceedings of the Revenue Divisional Officer, Ramanathapuram has been put to challenge in this writ petition.

2.Heard Mr.R.Saravanan, learned counsel for the petitioner and Mr.B.Thanaga Aravindh, learned Government Advocate appearing on behalf of the respondents 1 to 5 and 15 and Mr.D.Balamuruga Pandian, learned counsel appearing for the respondents 6 to 9, 11, 13 and 14.

3.On carefully going through the order, it is seen that that the Revenue Divisional Officer has only made a recommendation to the District Collector for the closure of 13th Madai and it is the District Collector who has to take a final decision.

4.The counsel appearing on either side submitted that till date the 13th Madai has not been closed. If that is so, the petitioner cannot
