2. The learned Additional Government Pleader appearing for the respondents submits that based on the joint patta, the petitioner alone has made a request for surveying the lands. In the event, all the pattadars have made a request for conducting survey, they would consider the same.

In view of the said submission, this writ petition is disposed of with a direction to the petitioner to submit a fresh application along with other pattadars for surveying the lands, within a period of two weeks from the date of receipt of a copy of this order. On filing such application, the respondents shall consider the same and conduct survey within a period of six weeks from thereon. No costs.
