The present Writ Petition has been filed by a Special Grade Conductor of the respondent Transport Corporation, who had attained superannuation on 31.03.2019 seeking the payment of interest for the belated disbursement of terminal benefits.

2. According to the learned counsel appearing for the writ petitioner, though the petitioner has retired from service on 31.03.2019, the terminal benefits were released only on 21.09.2019. Hence, the petitioner has addressed a communication to the respondent on 15.07.2024, seeking payment of interest for the belated disbursement of terminal benefits. Since there is no response, the present writ petition has been filed.

3. Heard the learned counsel appearing for the petitioner and the learned Standing Counsel appearing for the respondent.

4. Considering the above said facts, the respondent authority is directed to pay interest at the rate of 6% p.a., from the due date till the date of
