3. The only apprehension of the petitioner is that the respondents herein would resort to evict the petitioner, without following the due procedure contemplated under the Tamil Nadu Land Encroachment Act.

4. The learned Special Government Pleader submits that in case there is any encroachment in the subject lands, the same shall be removed, after following the due procedures provided under the Tamil Nadu Land Encroachment Act. In the light of such a submission, no further orders are required to be passed in this Writ Petition.

5. Accordingly, the Writ Petition stands closed. There shall be no order as to costs. Consequently connected miscellaneous petition is closed.
