Mr.B.Saravanan, learned Additional Government Pleader, appearing for the respondents 1 and 2, on instructions, would submit that the respondents do not have any intention either to cut or to remove the 7 tamarind trees standing in the petitioner's property. It is the neighbouring the land owners, who had removed the trees, as the branches had fallen on their rooftop.
