ORDER

The petitioner's request for transferring the patta to his name from his vendor mutt not having been considered for the past 6 months, the petitioner is before this Court.

2. The petitioner has purchased an extent of 4000 sq.ft in Survey No.3906 at Thiruthanthoni village, Uraiyur, Trichy district from Tharmapuram Aadhinam under a registered sale deed, dated 18.01.1988. The sale has been effected pursuant to the orders of this Court, dated 03.03.1987 in O.P.No.52 of 1986. The petitioner has made an online application on 25.03.2024 for the mutation of patta in his name. However, no steps have been taken and the status of his application simply shown as “pending for correction cannot proceed with this land”. However, no intimation has been received from the respondents.
