ORDER

The Writ Petition has been filed in the nature of Mandamus seeking a direction to the respondents to grant 30 days ordinary leave without Police escort to the husband of the petitioner, namely, Ramadass, son of Appadurai, who is a convict prisoner No.23087, now confined at Central Prison, Trichirappalli.

2. Though the Writ Petition had been filed on 18.09.2024, it is informed to us that even earlier on 08.09.2024 the representation given by the petitioner had been rejected by the second respondent.
