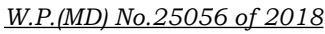
ORDER

The prayer sought for in this Writ Petition is to direct the respondents 2 to 4 to provide uninterrupted 3 phase power supply to the village Pethanendhal and Manalmedu, Sivagangai District.

2.Heard the learned counsel appearing for the petitioner and the learned Standing Counsel appearing for the respondents.

3.The learned Standing Counsel for the respondents would submit that insofar as the supply of electricity is concerned, it is being controlled by TANGEDCO and depending upon the availability of the power at a particular time as well as over all connections, restrictions are being made by TANGEDCO in distribution of electricity. Therefore, the petitioner cannot seek for a Mandamus to provide uninterrupted 3 phase power supply to the particular area.
