The present Writ Petition has been filed by an Assistant Professor working in Mathematics Department of a Private Aided College, seeking a Mandamus as against the second respondent for implementing the order dated 11.01.2024.

2. According to the learned counsel appearing for the petitioner, the Career Advancement Scheme (CAS) benefits were conferred upon the writ petitioner with effect from 07.12.2017 and the monetary benefits with effect from 01.08.2018 by the order of the second respondent. However, the said
