ORDER

This petition is filed as against the proceedings initiated by the first respondent as against the recovery proceedings initiated under Section 8F of the EPF and MP Act.

2.This writ petition was filed in the year 2017. When the writ petition was taken up for final hearing on 22.10.2024, there was no representation for the petitioner and therefore, this Court has directed the Registry to list the petition under the caption 'for dismissal'. Even today there is no representation for the petitioner.

3.The learned Counsel for the respondents submits that this petition has been filed as against the consequential proceedings without
