This is the second application for suspension of sentence. This Court, while dismissing the earlier application, which was filed on medical grounds, had directed the Registry to list the main appeal in the usual course.

2. This Court has also directed the learned Additional Public Prosecutor to get the status of medical condition of the petitioner. It is reported that the petitioner is being given treatment in the Ward of the jail hospital.

3. The learned counsel for the petitioner seeks time. Hence, the Criminal Miscellaneous Petition is dismissed.
