2. The I.D.O.P.No. 30 of 2020 was preferred by the wife to dissolve the

4. Accordingly, the marriage between the appellant and respondent is dissolved and this Civil Miscellaneous Appeal is allowed. The Memorandum of Understanding is forming part and parcel of this Judgment. No Costs.
