3.Considering the above facts and nature of offence, the condition imposed on the petitioners/appellants is modified to the effect that the petitioners shall appear



and sign before the respondent Police on the first working day of every month at 10.30a.m., without fail until further orders.

4. Accordingly, these petitions are ordered.
