In view thereof, I am not able to agree with the contention of the learned counsel for the petitioner. Though it is a simple case of a love affair and elopement, in view of the serious nature of offences, this is not a fit case for enlarging the petitioner on bail.

4. Accordingly, this Criminal Original Petition is dismissed.
