Considering the nature of allegations that that the recovery is a huge haul of 1107 bottles of liquor and considering the material so far gathered against the petitioner that he spoke to the other prime accused on the day of occurrence several times and that the consignment was destined to the address of the petitioner, for the present I am not inclined to enlarge the petitioner on bail.

4. Accordingly, this Criminal Original Petition is dismissed for the present.
